

## STRATEGY DESCRIPTION

The investment strategy operates Emini futures during normal stock market regimes, SDS and SSO leveraged etfs in high volatility regimes . Trades are both long or short. More than 400 daily bars patterns are run every day to forecast the overnight session bias that triggers the trade. Markov chains philosophy is followed to keep the algos updated.
